

## **Consignment Agreement with The Closet**

Thank you for choosing to sell with us! Please read this form carefully and sign your name and signature where required. Be sure to place the completed form inside your Thrift Bags before sending them back.

### We accept:

- New or near new women's clothing
- New or near new women's shoes
- New or near new women's activewear
- Women's unworn swimwear and intimate wear (must be new with tags and protective liners)
- New or near new women's accessories (bags, wallets, clutches and belts)
- Jewellery (necklaces, bracelets, new with tags earrings, sunglasses, and watches)

We only accept **mid-priced**, **premium**, **and designer brands**. We **do not** accept fast fashion brands due to the low prices that we fetch for them and the very high rate of returns. Fast fashion items will be rejected even if they are new with tags.

We encourage sellers to send in plus-size clothing and shoes as we want to increase our offering of stylish and on-trend fashion for women of all sizes, but as CITY CHIC and TAKING SHAPE clothing are not in-demand and do not sell well, we are currently **not accepting** them at this stage.

#### **Quality standards:**

Please ensure your clothing is **freshly laundered or dry cleaned** before you send them to us. Items that are new with tags do not have to be laundered if they present in a brand new and unworn state and there are no apparent odours. Similarly, shoes, handbags and accessories must be cleaned before sending.

We will not accept any items that are:

- Showing signs of wear,
- Stained or dirty,
- Have odours, rips, tears, stretching or pulling,
- Items that are faded, have shrunk, or are blemished in any way,
- Items that have been altered after purchasing.
- Shoes that are dirty, scuffed and appear obviously worn.
- Items need to have all sizing and material tags intact.
- Items more than five years old (except authentic premium and designer vintage items).
- Clothing displaying inappropriate or offensive messages, words, or images, outdated and old-fashioned items (except for high-quality vintage items).
- Any form of slippers, hair accessories, work uniforms or costumes.
- Home-made items.
- Items with brand and size tags removed.
- Fake or counterfeit items, items obtained illegally
- 'niche' items that will only appeal to a very limited audience.

Items that are expected to take longer to sell, but still in very good condition will be accepted and listed at The Closet's discretion.



#### **Terms and conditions:**

The initial listing price for consigned items will be determined by The Closet at their absolute and sole discretion. If your clothes do not sell within 9 weeks of listing, The Closet, at its discretion, may decide to reduce the listing price by up to 50%. If the item remains unsold for a total of 12 weeks, The Closet may deactivate the online listing and re-list it at a later date, or return it to you, or donate it to a charity depending on your preference as indicated on your Consignment Agreement. This will be done without notice.

Only after this time, your items will be posted back to you if you have selected this option on your consignment form and you will be responsible for postage costs. You may choose to donate your unsold items to one of the charities supported by The Closet. Please indicate your preference relating to how we deal with your consignment items on the form.

Your payout is a percentage of The Closet's selling price. It increases with the selling price and is subject to change. The following table sets out the percentage of the selling price that you will be paid for individual items. Sale price is inclusive of GST.

You can indicate and amend your preferred method of being paid at any time. Upfront payments are made at the time of processing and payments as and when items have been sold are made once a month.

If a purchasing customer returns an item to us, the item will become the property of The Closet to deal with as it wishes. Whilst the risk of returns are ours and we will not ask for money back from you, The Closet will not be liable for any damages or loss of your items, regardless of who caused the loss or damage. Unless otherwise specified, you guarantee authenticity of consigned goods and indemnify The Closet of any damages, fees, and costs that may occur, including return of buyer's purchase price, as a result thereof. Additionally, you warrant legal ownership of all items free of any liens and encumbrances.
